The legal process of changing a name varies from State-to-State. Below is the generally process followed by a majority of States.

- 1. Filing a Petition:** To legally change your name in most states, you must file a Petition for Change of Name with the Superior Court. This petition requires detailed information including your current legal name, the new name you wish to adopt, and the reasons for your name change. It's crucial to ensure that all information is accurate and complete to avoid delays in the process.
- 2. Public Notice:** After you file your petition, the State generally requires that you publish your intent to change names in a local newspaper. This publication must run once a week for a certain number of consecutive weeks (the average is 4 weeks). The purpose of this requirement is to publicly announce the change, allowing anyone with a valid objection to the name change to come forward.
- 3. Court Hearing:** Following the publication period, a court hearing will be scheduled. During this hearing, the judge will review your case, consider any objections, and decide whether to approve your name change. Assuming there are no compelling objections, the court typically grants the petition.

**Exceptions to Public Notice:** In certain cases, such as when the name change is sought for safety reasons related to domestic violence or stalking, the court may waive the publication requirement to protect the petitioner's privacy and safety.

**Name Changes for Minors:** Changing a minor's name involves additional steps to protect the child's interests. Both parents generally must consent to the name change, and additional documentation, such as consent forms or legal notices to absent parents, may be required. If parental consent is not unanimous, the court will consider the child's best interests in deciding whether to grant the name change.
