**Elder Abuse** is any action or omission that harms a senior citizen (generally someone over the age of 65, but this may vary from state-to-state). It is used most often to describe frequent abuse or an ongoing pattern of elder mistreatment. Elder abuse can refer to neglect and exploitation as well as multiple types of abuse. It may be committed unintentionally, such as by a careless or negligent caregiver, or intentionally, in a knowing attempt to harm the victim. We are proud to assist Elders who have been, or are currently, victims of Elder Abuse. We are able to assist with all types of Elder Abuse, including (but not limited to):

- ***Physical Abuse:*** This abuse may be the result of direct physical contact, such as hitting or kicking. More often, it is the result of negligence. Someone who has been charged with caring for an elderly person fails to fulfill his or her duty. The result of physical elder abuse may be bedsores from improper care, broken bones caused by falls due to improper supervision, malnutrition, dehydration, and more.
- ***Emotional Abuse:*** This type of elder abuse can come in the form of verbal mistreatment, such as constantly yelling at someone, isolating him or her in a room for long periods of time and other similar acts. Emotional elder abuse in Los Angeles can have a detrimental impact on a senior citizen's well-being and health.
- ***Financial Abuse:*** Con artists can come in all shapes and sizes. Often, they may appear fairly legitimate. They may drag an elderly victim into bad investments or other financial schemes. Other cases may involve outright theft of money or property, or stealing and forging checks.
